
7. Profile of Gender Composition

a scientific approach in the rural students of farmers and workers. The number of students of the Science faculty with the male female ration is shown below with table and graphical form.



In the Gymakhana department all sport activities was conducted. The students are involved in various games like Kabbadi, decathlon, athletics, swimming and so on




For the analysis of gender balance, we prepared a questionnaire related to gender equality. 149 students participated in this survey and the compiled data is analyzed.
